Hugo Sinzheimer Moot Court Competition

The Hugo Sinzheimer Moot Court Competition (HS MCC) is an initiative from five befriended labour law academics. The aim of the HS MCC is to deepen and improve the knowledge of employment and labour law at the European level. It offers an opportunity to experience the operation of European labour law in an as realistic setting as possible.

HS MCC is a competition in European Labour Law. The competition imitates real life court situations and addresses the most challenging and topical issues within the field. During the competition the teams prepare written statements and oral pleas for a jury panel consisting of judges and experts.

The first HS MCC took place in Amsterdam on 24-25 June 2016. This year the event takes place in Aarhus, Denmark on 15-17 June 2017.

HS MCC is a great opportunity to meet students, professors, practitioners and maybe future colleagues from different countries in Europe. Have fun and enjoy the competitions and networking during the Finale.

About Hugo Sinzheimer

The Competition is named after the German scholar and lawyer Hugo Sinzheimer (1875-1945). Hugo Sinzheimer is widely regarded as the founding father of labour law. Not only in Europe, but also internationally his works have had a profound impact. Sinzheimer, who united various perspectives on labour law, stands for a concept of social labour law.

Sinzheimer, with a PhD in law and economics from the University of Heidelberg, later became honorary professor of labour law and sociology of law at the University of Frankfurt. In 1933, Sinzheimer, who was Jewish, was forced to flee to the Netherlands. He immediately obtained a professorship in sociology of law at the University of Amsterdam, which in 1936 was followed by a second professorship in Leiden.

As a member of Weimar National Assembly, Sinzheimer was also actively involved in the construction of the Weimar Constitution, which contained rights regarding freedom of coalition and employee participation.

Since 1993, the Hugo Sinzheimer Institute of the University of Amsterdam has carried his name. In 2010, the Hugo Sinzheimer Institut für Arbeitsrecht was founded in Frankfurt am Main, Germany. The Hugo Sinzheimer Moot Court Competition is institutionally embedded at The Hugo Sinzheimer Institute at the Law School at the University of Amsterdam.



About Aarhus BSS

The 2nd of the Hugo Sinzheimer Moot Court Competition is hosted by the Department of Law, Aarhus BSS, Aarhus University.

Aarhus University was founded in 1928 making it the second oldest university in Denmark. With approximately 42,500 students and 11,500 employees, Aarhus University is Denmark's largest university. Aarhus University is ranked in the top 100 by several influential rankings.

Aarhus University is divided into four faculties, one of which is Business and Social Sciences (also called Aarhus BSS). Aarhus BSS is further divided into six academic departments, including the Department of Law.

Aarhus BSS is one of the largest business schools in Europe with approximately 13,000 students, nearly 2,000 part-time students, almost 250 PhD fellows and close to 600 faculty members. The venues

The City Hall

The venues chosen for the Hugo Sinzheimer Moot Court Competition 2017 are all of significance in each their own way.

The welcoming ceremony will be held at the City Hall of Aarhus in the heart of the city. Centrally located a few hundred yards from the Central Station lies the architecturally distinct City Hall.

Designed by renowned architect and furniture designer Arne Jacobsen and clad with Norwegian marble, the City Hall is one of a few to have been chosen for preservation due to the uniqueness in material and design choices. Known for its distinctive clock which is regularly featured as backdrop on the Danish news, it is truly recognisable by all Danes.



The University

Aarhus University's main campus is the University Park.

Tall yellow walls house students and academics, all sharing the wonderful oasis in the middle of the city. A tiny lake fringed with trees and winding slopes of green grass brings calm tranquillity, often juxtaposed by the stress experienced by the students inside the walls when exams creep up on them. Once a year 20.000 students and faculty gather in the park for the yearly regatta. A whole day dedicated to brave men and women crossing the treacherous lake, filling the park with joy, music and high spirits.

The Department of Law is located on the steep "Law Hill" close to the main auditorium, "Aulaen". The Hugo Moot Competition will be held here on Friday.

Last year the Department of Law finished building a brand new state of the art court room on campus located just above "Aulaen". The Max Sørensen court room provides the right practical setting to law classes and various moot court contestants and imitates real life court situations perfectly. It will surely be put to good use on Friday the 16th.



Tinghuset

Back in the beating heart of the city is the newly renovated District Court building called "Tinghuset". The impressive building from 1906 is situated some hundred yards from the City Hall, in solitude to the side of a downhill road, not surrounded by other buildings.

Across from the District Court lies the renowned ARoS Aarhus Art Museum which features the now iconic My Rainbow Panorama made by the world famous Danish-Icelandic artist Olafur Eliasson.

The finals of the Moot Court Competition will take place in the historic courthouse which has heard countless legal pleadings throughout the years.

Since 1906 the building has played a role in Danish legal history, first as a combined courthouse and jail, and now following the renovations as solely a courthouse. The renovations have brought renewed energy into the old building, with improved facilities for all the actors in legal proceedings. When the finals take place in this historic landmark it will certainly add a practical atmosphere not only to the contestants' pleadings, but to everyone involved.



Dr. Ronald Beltzer, Professor, University of Amsterdam (The Netherlands)

Chair of the Organising Committee

Director of the Hugo Sinzheimer Institute at the University of Amsterdam, and chair of the Organising Committee, Hugo Sinzheimer Moot Court Competition. He is professor of labour and company law at the University of Amsterdam, and former guest professor of Vytauto Didžiojo University (Lithuania). He serves as editor on multiple journals on labour law and company law. Furthermore, he is a judge at the Amsterdam Court of Appeal as well as an adviser to the Dutch law firm, Liber Dock.



Dr. Manfred Weiss, Professor emeritus, Goethe University in Frankfurt (Germany)

Chair of the Advisory Board

Chairperson of the Advisory Board of Hugo Sinzheimer Moot Court Competition. Professor emeritus of labour law and civil law at Goethe University in Frankfurt. He has inter alia been President of the International Industrial Relations Association (IIRA), consultant to the ILO and consultant to the Commission of the EU. He is honorary professor of the University of Cape Town as well as extraordinary professor of NWU, University of Stellenbosch and UWC. He is the author of numerous books and articles in the field of labour law, European labour law, and industrial relations. In 2015, he received the LLRN-Award for outstanding contributions to labour law.



Dr. Annamária Fűrjes, Judge, Budapest-Capital Administrative and Labour Court (Hungary)

Judge at the Administrative and Labour Court in Budapest in the labour law division. Her Ph.D. is on "Social Security Coordination in the European Union - with focus on pensions" from Szeged University, Faculty of Law. Furthermore, she has published labour law related articles in multiple journals.

**Dr. Bálint Rózsavölgyi, Judge, Debrecen Administrative and Labour Court (Hungary)**

Judge at Debrecen Administrative and Labour Court. Former court clerk at the Debrecen Court of Appeals. His professional interests cover the application of EU legislation in Hungary, including conflict of laws, the free movement of workers, and he has participated in preliminary rulings before the European Court of Justice as well as cross-border legal cooperation.

**Dr. Gaabriel Tavits, Professor, Practicing lawyer, University of Tartu (Estonia)**

Professor of Social Law at University of Tartu. He serves as national expert on the "European Centre of Expertise in the field of labour law, employment and labour market policies" (ECE). He has a broad teaching experience and numerous publications within the field of labour and social security law. In addition, he acts as practicing lawyer. He is also training expert and consultant by Ernst and Young, Italy, responsible for European labour law and social security law.



Dr. Gábor T. Fodor, Partner, Attorney, “Ferencz, Fodor T. Kun & Partners”, Budapest (Hungary)

Partner and Attorney at “Ferencz, Fodor T. Kun & Partners” in Budapest with a main focus on labour law. He has a broad experience in litigation in this field of law. He is a recognised lecturer as well as an author of labour law articles in Hungarian and English. He is a co-author of The Guide to Labour Law, one of the Hungarian authors of EIRO, censor of the legal qualifying board, and author of several studies on labour law.



Dr. Jean-Michel Servais, Professor, President of ISLSSL, former ILO, Geneva (Switzerland)

Member of the Advisory Board of Hugo Sinzheimer Moot Court Competition. Honorary President of the International Society for Labour Law and Social Security, visiting professor of University of Gerona. He has served with the ILO in Geneva from 1972 to 2005, where he inter alia held positions as Deputy Regional Director for Asia and the Pacific, Research Coordinator at the International Institute for Labour Studies, and Director of Operations at the ILO Regional Office for Arab States. He is the author of numerous books and articles in the field of international and comparative labour law and industrial relations.



Jesper Svenningsen, Judge General Court, Court of Justice of the European Union (Denmark)

Judge at the General Court of the EU since September 2016. Former judge at the Civil Service Tribunal of the EU. He has served as legal secretary at the Court of Justice for two Danish judges and worked as an attorney, inter alia, with the Legal Adviser to the Danish Government. He has lectured at University of Copenhagen and at the European Institute of Public Administration (EIPA). Judge Svenningsen participated as jury-judge at the Hugo Sinzheimer Moot Finale in 2016 in Amsterdam.



Karsten Hagel-Sørensen, Attorney, former Legal Adviser to the Danish Government (Denmark)

Partner and attorney at Kammeradvokaten – Law Firm Poul Schmith for 25 years, 10 of which he held the esteemed position as 'Kammeradvokat', i.e. Legal Adviser to the Danish Government. He also served 18 years at the Ministry of Justice, working with EU-law and international law. He has extensive litigation experience before the Supreme Court as well as the EU Court of Justice. He has published extensively on EU- and International Law. In 2006, he was appointed honorary professor at Aarhus University.



Dr. Lukasz Pisarczyk, Professor, Warsaw University (Poland)

Member of the Advisory Board of Hugo Sinzheimer Moot Court Competition. Extraordinary professor at the Division of Employment Law and Social Policy at the Faculty of Law and Administration of the University of Warsaw. Director of the Postgraduate Program in Employment Law. Secretary General of the Polish Section of the International Employment Law and Social Security Association. He has received a second-degree award for academic achievement. Author of numerous studies, articles, books and glosses. Professor Pisarczyk participated as jury-judge of the Hugo Sinzheimer Finale in 2016 in Amsterdam.



Dr. Martin Risak, Associate professor, University of Vienna (Austria)

Associate professor at the Department of Labour Law and Law of Social Security at the University of Vienna, Austria. Among other functions Martin is the chairman of Senate II of the Austrian Equal Treatment Commission and the Austrian national expert of the European Centre of Expertise in labour law, employment and labour market policies (ECE) that advises the European Commission. He has published 16 books, and more than 120 articles and book chapters, primarily in the fields of Austrian, European and international labour law, the law of social security, and dispute resolution.



Dr. Péter Sipka, Assistant lecturer, Attorney, University of Debrecen (Hungary)

Assistant lecturer at the Faculty of Law, University of Debrecen. He is also an attorney at law. His main research areas are labour and social law; more specifically compensation in labour law, the connection between OSH regulations and the liability in labour law, the collision of the changed employer's liability with the regulation of the occupational health and safety and social security in Hungary. He has produced several publications concerning labour law.

**Dr. Vincenzo Pietrogiovanni, Senior lecturer, Lund University (Sweden/Italy)**

Senior lecturer at Department of Business Law at Lund University. His research areas include labour law, industrial relations, international labour standards and social justice. He is a member of Lund Human Rights Research Hub. He has a broad teaching experience and numerous publications within the field of labour law.
